**PLEASE NOTE: Membership fees are due April 15th, 2022. Family membership includes Spouse/Partner and up to an addition of 3 immediate family members, 18 yrs. old or older, for a total of five (5). Immediate family includes adult sons & daughters, grand-children, aunts & uncles, grandparents, cousins, etc.**

**I. (we) have read and agree to abide by the following Rooster Tails Fishing Club (the Club) rules and requirements below:**

1. The definition of a Rooster Tails Fishing Club Member is a man, woman, or family member **18 years old or older** that is interested in fishing and fishing related issues who has signed this application and a liability waiver, and submitted an accompanying annual dues check.
2. No insurance is provided for Club members, nor their guests, for transportation to or from any Club sanctioned fishing outings, fishing tournaments, or other Club functions.
3. Only Club members qualify for prizes in Club Fishing Tournaments. Each Club member interested in participating must sign-up in advance and pay any applicable tournament entry fee. A Club member must be in good standing with paid annual dues in advance of participating in a Club fishing tournament. Cash-pots/bets/jackpots that are not sanctioned in writing by the Club's Board of Directors are prohibited. Only Club members qualify for the Club's Annual Jackpot Contest as per the contest rules. Non-member invited guests that fish in any club fishing event must be signed-up in advance of the event.
4. Fishing event participants are recommended to have a VHF marine radio set to channel 68 and to keep on-board boat safety equipment for each person as defined by the California Division of Boating and Waterways State Requirements.
5. All Club members, their guests, and family members agree to promptly report any accident they observed or were part of to any member of the Club's Board of Directors. Each member is solely responsible for the safety and activities of their invitees and guests.
6. All individuals, including Club members and visitors, attending Club breakfasts, fishing outings, and other Club events are prohibited from soliciting, selling, or otherwise providing offers to participate in other organizations or to purchase goods/services without prior approval by the Club's Board of Directors. Only prior Board approved flyers, brochures, offers for services and business cards are allowed at Club events.
7. The Club does not publish a membership directory or roster nor deliberately release member address information to minimize unwanted contact or solicitation. Members are prohibited from sharing, selling, or other-wise distributing telephone contact information from the Club's web site Members-Only tab.
8. Club members wishing to participate in club organized meetings, fishing outings, fishing tournaments, and special events are **required to have their signature on a Release and Waiver of Liability, Assumption of Risk Agreement on file with the Club before signing-up to participate.**
9. New Members who pay dues 2 months prior to April 15<sup>th</sup>, 2022 will be entitled to membership for April 15<sup>th</sup>, 2022 through April 15<sup>th</sup>, 2023

**RELEASE OF LIABILITY**

The Rooster Tails Fishing Club of Northern California, Inc., (*here forth referred to as Club*), attorney advises the purchase of liability insurance to protect the Club and its members. In addition, for the Club to hold meetings and other activities in the Auburn Elk's Lodge, or in RV parks, and marinas require our Club to have insurance and for them to be shown as additionally insured on our policy. By signing this waiver, the Club does not avoid responsibility for Club negligence, but that it does not accept responsibility for unrelated ordinary slips, falls, and injuries that are part of all sports, including fishing related activities to the extent that Club did cause the injuries. If you wish to participate in fresh or saltwater fishing outings organized by the Club the following release and waiver of liability, assumption of risk agreement must be signed in advance as a requirement of being a Club Member. You may choose to make a copy of this document to be retained for your records. Thank you for your understanding and appreciation of protecting you and your organization in today's society.

**RELEASE AND WAIVER AND ASSUMPTION OF RISK AGREEMENT**

*Please read carefully before signing this release of liability and waiver of your certain legal rights. In consideration of being allowed to participate in the Rooster Tails Fishing Club of Northern California, Incorporated, (hereafter as **Club**) coordinated events held for your enjoyment, including fresh and saltwater fishing outings, special fishing outings, by signing this document, you agree to the following:*

I/we, \_\_\_\_\_ (*clearly print **all applicant names***) hereby acknowledge and fully understand that I/we will be engaging in activities that may involve risk of damage to personal property, or serious injury, including permanent disability, death, severe social, and economic losses which might result not only from my own actions, inactions or negligence, but the actions, inactions or negligence of others, as a result of engaging in club organized fishing outings, camp rallies, boat related launching/retrieval, including but not limited to perils of water hazards, acts of other participants, adverse weather conditions, and I hereby assume complete responsibility and liability for such risks. In addition, I acknowledge there may be other risks not known or not reasonably foreseeable during other Club coordinated events. I certify that my physical condition and experience is adequate to enable me to participate in fishing outings, fishing tournaments, and camp rallies. I understand that I have responsibilities for my own safety and the safety of other Club members and my guests. Furthermore, I fully understand that my transportation to and from fishing, camping, and other Club organized events is solely my responsibility for myself, my family, and my guests.

I hereby agree to release, waive, discharge, indemnify, and hold harmless the Rooster Tails Fishing Club of Northern California, Inc., its directors, officers, agents, volunteers, and affiliates, of all claims, demands, causes of actions, liabilities, losses, damages, and costs that may arise. I further agree that this release and waiver of liability shall bind the members of my family and spouse, my heirs, assigns, and personal representatives. This waiver may not be modified in any way. If any part of this release and waiver is determined to be invalid by law, all other parts of this release and waiver shall remain valid and enforceable. This agreement shall remain in force until revoked in writing by me.
